

## **Local Citizen Participation Plan**

Crawford County, Ohio Community Development Block Grant (CDBG) Program Year 2023 March 23, 2023

## 1. Background

The Community Development Block Grant (CDBG) Program is a federal grant program through the Department of Housing and Urban Development that provides annual grants on a formula basis to states, cities, and counties to develop viable urban communities by providing decent housing and a suitable living environment, and by expanding economic opportunities, principally for low- and moderate-income persons. The program is authorized under Title 1 of the Housing and Community Development Act of 1974.

For Program Year 2022, the State of Ohio received \$45.2 million in CDBG funds For Program Year 2023, Crawford County, Ohio is eligible to apply for and receive federal Community Development Block Grant (CDBG) funds from the Office of Community Development of the Ohio Department of Development. They include the following programs and project amounts:

### Community Development Allocation

- Grant funding for community development projects such as construction or improvement of public facilities, demolition of blighted buildings, projects to increase accessibility to the handicapped and elderly, and preservation of historic buildings or areas.
- o Available funds: \$220,000.

## • Critical Infrastructure

- Competitive grant funding for projects designed to address high-priority improvements such as roads, storm damage, fire protection facilities, and other public facilities.
- Available funds: up to \$500,000.

### Neighborhood Revitalization

- Grant funding to improve quality of life, livability and functionality of distressed areas and neighborhoods. Eligible activities include public facilities, improvements in targeted areas of distress that do not fit within the criteria of other CDBG competitive programs.
- Available funds: up to \$750,000.

### • Residential Public Infrastructure

- Grant funding for water and/or sanitary sewer projects to primarily residential users.
   There is a minimum total project cost of \$200,000, and the project must be located in an area that has a low- to moderate-income population of at least 51 percent.
- Available funds: up to \$750,000.

### • Flexible Grant Program

- Grant funding for eligible activities which do not fit with other CDBG programs. Eligible projects include economic development, community development, housing and downtown activities.
- Available funds: amount varies.

## 2. Citizen Participation Plan

According to the Ohio Department of Development's Program Year 2023 Ohio Consolidated Action Plan In order to receive these funds, the Crawford County Board of Commissioners "must adopt and follow a written local citizen participation plan which" addresses the following topics:

- LMI Participation: "Provides for and encourages citizen participation, with particular emphasis on participation by persons of LMI (low- to moderate-income) who are residents of slum and blighted areas and of areas in which Section 106 funds are proposed to be used, and in the case of a grantee described in Section 106(a), provides for the participation of residents in low- and moderate-income neighborhoods as defined by the local jurisdiction."
- Public Hearings: "Provides for public hearings to obtain citizen views and to responds to
  proposals and questions at all proposed activities and program performance, which hearings
  shall be held after adequate notice, at times and locations convenient to potential or actual
  beneficiaries, and with accommodation for the disabled."
- Technical Assistance: "Provides for technical assistance to groups representing persons of LMI
  that request such assistance in developing proposals with the level and type of assistance to be
  determined by the grantee."
- **Complaints & Grievances:** "Provides for a timely written answer to written complaints and grievances, within 15 working days where practicable."
- Proposed Use of Funds: "Provides citizens with reasonable and timely access to local meetings, information, and records relating to the grantee's proposed use of funds, as required by regulations of the Secretary, and relating to the actual funds under this title."
- Non-English Speakers: "Identifies how the needs of non-English speaking residents will be met
  in the case of public hearings where a significant number of non-English speaking residents can
  reasonably be expected to participate. This paragraph may not be construed to restrict the
  grantee's responsibility or authority for developing and executing its community development
  program."

### 3.2 Public Hearing 2 – Proposed CDBG Activities

Mansfield St., Suite 304, Bucyrus, OH 44820. Legal notice will be provided in both the Bucyrus Telegraph-Forum and Galion Inquirer on Monday, May 1, 2023, and on Monday, May 8, 2023.

The following is information that will be conveyed and program areas to be discussed:

- A presentation on the county's proposed CDBG program, including the activity or activities to be
  undertaken, the amount of CDBG and other funds allocated for each activity, the objective of
  each activity, the timetable for starting through completion of each activity, and what national
  objective(s) each activity will meet.
- A written summary of the proposed CDBG program.
- Citizen views and comments.

The notification strategy supplementing the legal notices will be similar to that used for Public Hearing 1.

## 3.3 Public Hearing 3 – Amendment

If there is a program change following the second public hearing, and if the Office of Community Development determines that the program change constitutes an amendment, then one additional public hearing will be required. The primary purpose of this "Amendment Public Hearing" is to provide citizens with an opportunity to review and comment on a "substantial change" in the County's CDBG program. The format will be similar to that for Public Hearing 2. Legal notices and additional notification will be provided as needed.
