AUTHORIZING THE SUBMISSION OF THE PY 2023 CDBG PROGRAM APPLICATIONS: CDBG ALLOCATION GRANT WITH THE STATE OF OHIO ON BEHALF OF CRAWFORD COUNTY

Doug Weisenauer made the motion to adopt the following

WHEREAS, Crawford County is applying for funding from the State of Ohio, Department of Development, Office of Community Development (OCD) for the purpose of addressing local needs through the Community Development CDBG Programs for PY 2023 Allocation;

WHEREAS, the State of Ohio, Department of Development, provides communities with a flexible housing and community development resource that can be used to address locally identified needs that are eligible Community Development Block Grant (CDBG) activities and qualify under the national objective of Low- and Moderate-Income (LMI) Benefit or Elimination of Slum and Blight.

WHEREAS, Crawford County, Ohio wishes to participate in, and receive financial assistance in the amount of \$220,000 through the 2023 CDBG Community Development Allocation Program provided through the State of Ohio, Department of Development;

WHEREAS, Crawford County, Ohio wishes to direct and authorize Crawford Partnership to act in connection with said Program Applications, and provide such additional information as may be required; now, therefore, be it

RESOLVED, by the Board of Commissioners, Crawford County, Ohio:

Section 1: That Crawford County authorizes Crawford Partnership, to file a PY-2023 CDBG Community Development Program Application(s) with the State of Ohio, Department of Development, and to provide all information and documentation required in said Application submission.

Section 2: That Crawford County hereby approves the filing of said Application by the June 14, 2023 deadline.

Section 3: That Crawford County hereby understands and agrees that participation in said Program will require compliance with program guidelines and assurances.

Section 4: That the Commissioners hereby understand and agree, that the community as a recipient of CDBG funds will affirmatively further Fair Housing, develop proposed actions to affirmatively further fair housing, seek and obtain state approval of the proposed program, and implement the proposed actions

Section 5: The Crawford County Commissioners executed a Contract for Services for the PY-2023 CDBG Community Development Programs for Administration and Implementation Services with the Crawford Partnership. However, the agreement in only enforceable upon funding of the PY 2023, therefore contingent upon funding from the State of Ohio, Development Services Agency. Crawford Partnership is to work with and at the direction of the Crawford County Commissioners in order to assure that all services, information and documentation required by said Agreements, HUD, the State of Ohio and/or CDBG guidelines are provided; and, further be it

RESOLVED, this resolution also authorizes the president and/or vice president of the board of commissioners to sign any and all documentation related to the execution of said contract/agreement.
